Applicant may apply to the Fish and Wildlife Commission for a hunting permit allowing such person to hunt on the Umatilla Indian Reservation under the following conditions:

- (1) The permit shall allow hunting only for deer and elk;
- (2) The hunting shall be valid during the regular hunting season open for Section "A" and "B" tribal members or such other period as specifically identified by the Fish and Wildlife Commission on the permit;
- (3) The hunting permit shall only be valid within the **diminished boundaries** of the Umatilla Indian Reservation;
- (4) The permit shall specify the number of animals that may be taken; and
- (5) The tribal member receiving a permit pursuant to the Wildlife Code shall file a kill report to the CTUIR Wildlife Program, 46411 Ti'Mine Way, Pendleton, OR 97801 within 3 days (72) hours of taking of an animal/close of season pursuant to a permit issued under this section. The report shall indicate the species and gender of the animal killed, the date of the kill, and the general location of the kill. A kill report shall also be filed with the CTUIR Wildlife Program in the event that no animal is taken under the permit.
